

## Investment Objective

To provide exposure to investment grade global asset backed securities (ABS) and generate stable income with some capital growth.

## Portfolio Returns

The Bentham Asset Backed Securities Fund had a total return (after fees) of 0.89% in the month of October, outperforming the benchmark (Bloomberg AusBond Bank Bill Index) by 0.65%. On a before fees basis the fund returned 0.95% for the month, outperforming the benchmark by 0.71%.

## Portfolio Exposures

The Fund's sector allocations are 34.8% in US Broadly Syndicated Collateralised Loan Obligations (CLO), 25.9% in European CLO, 12.2% in Middle Market CLO, 8.0% in Australian Residential Mortgage Backed Securities (RMBS), 6.2% in UK RMBS, 5.2% in Cash & Derivatives, 3.2% in Aircraft ABS, 2.6% in Credit Card ABS, 1.2% in US Commercial Real Estate (CRE), 0.5% in European RMBS, 0.2% in Auto ABS and 0.0% in Personal Loan ABS.

## Contributors

The top performing contributors to performance included European CLO and US Broadly Syndicated CLO; whilst the bottom performing contributors included UK RMBS and Middle Market CLO.

## Outlook

The Fund remains focused on the higher rated tranches of ABS issuance, offering investors a high credit quality, higher yielding, secured alternatives to investment grade corporate and government bonds, with low interest rate risk.

We place a high value on the structural benefits ("terms") typically included in global ABS structures to help preserve the principal of investors in the higher-rated tranches, such as cashflow priority, security, seniority, and reduction in leverage over time.

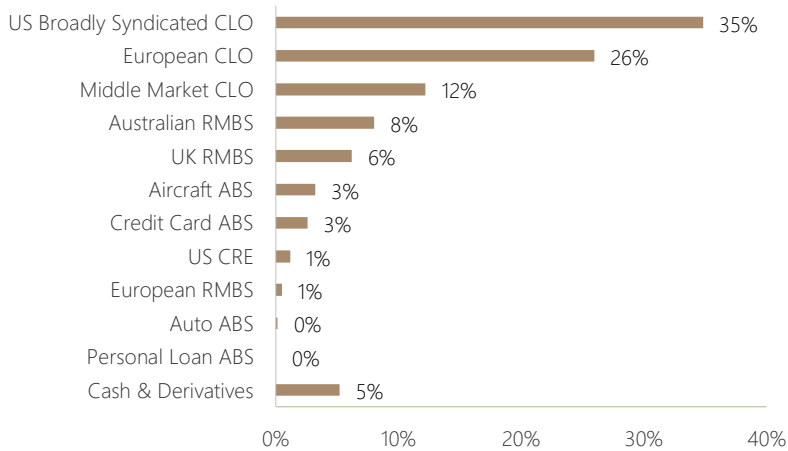
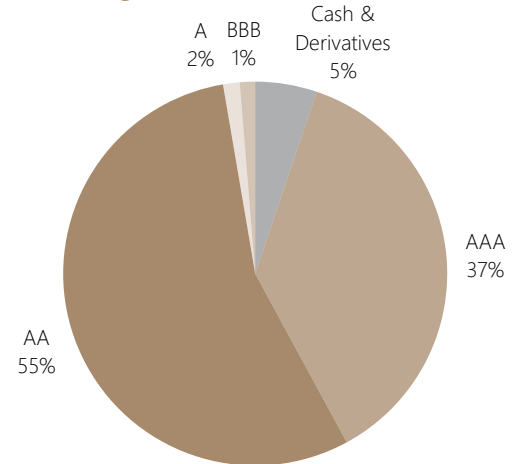
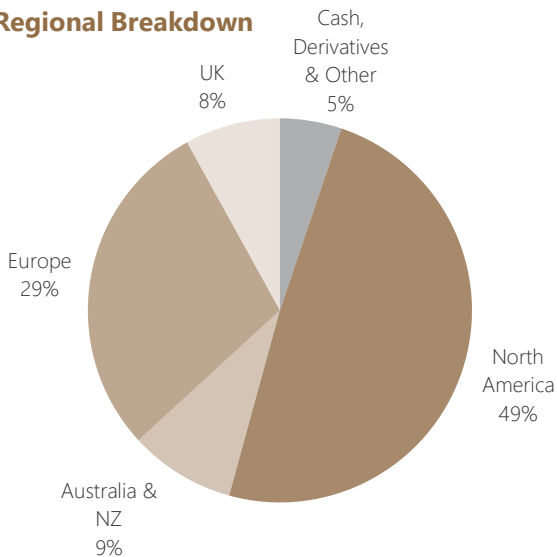
