Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 1.60% in the month of March, outperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index³ (hedged into AUD) by 0.60%. On a before fees basis the fund returned 1.66% for the month, outperforming the benchmark by 0.66%.

High Yield Market

For the month, 20 of the 23 industries had positive returns. The top performing industries in March were Food/Tobacco, Utility and Metals/Minerals with returns (sector performance in USD terms) of 3.06%, 2.93% and 2.76% respectively. The worst performing industries were Broadcasting, Telecommunications and Financial with returns of -2.63%, -0.51% and -0.04% respectively.

The credit yield spread for the Index increased by 35 bps during the month to 453 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 11.7% in Diversified/Conglomerate Service, 9.9% in Electronics and 7.6% in Buildings and Real Estate. The Fund's top three company exposures are 1.4% in Nfp, 1.2% in Speedway Motorsports and 1.1% in Foundation Building Materials. During the month, the Fund increased its exposure to Vertiv, Encore Capital and Boyne USA; with decreased exposures to Telenet Finance Luxembourg Notes, Ciena and Radiology Partners.

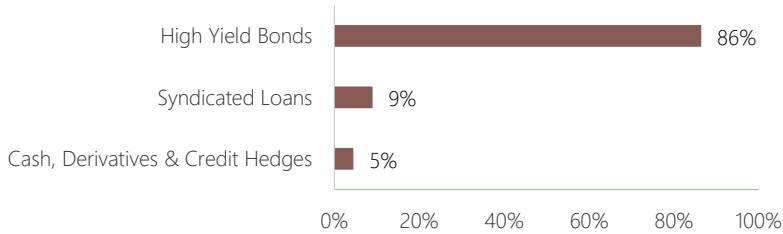

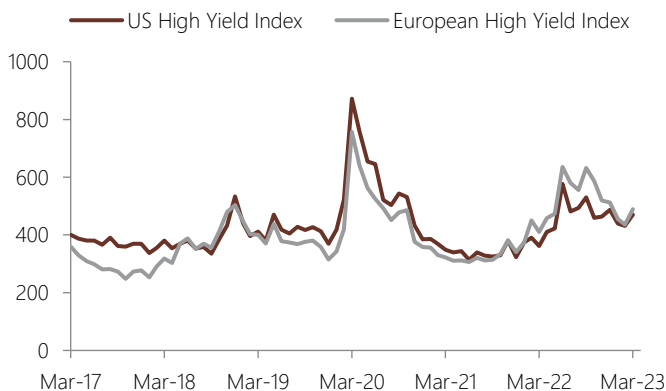
