To provide diversified exposure to securities across global credit markets, with the flexibility to adapt its credit and cash exposure to suit market conditions across the credit cycle, and deliver consistent levels of income.

### Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of -1.73% for the month, underperforming the benchmark by 2.02%. The top performing contributors to performance included Collateralised Loan Obligations (CLO), Capital Securities and Asset Backed Securities (ABS); whilst the bottom performing contributors included Global Syndicated Loans, Investment Grade Credit and Global Hybrids.

### Portfolio Asset Allocation

During the month, exposures to Cash, Basis Trades and Government Backed Bonds (Emerging Market) increased, whilst exposures to Global Syndicated Loans, Global High Yield and Investment Grade Corporate Credit decreased. Current asset allocations are 49.2% in Global Syndicated Loans, 8.6% in Capital Securities, 5.5% in Collateralised Loan Obligations, 3.8% in Investment Grade Corporate Credit, 2.3% in Global Hybrids, 1.3% in Asset Backed Securities, 0.4% in Equity, 0.3% in Residential Mortgage Backed Securities, 0.1% in Convertibles, -1.3% in Government Backed Bonds (EM), -1.4% in Global High Yield and 31.3% in Cash, Derivatives & Credit Hedges.

### Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 16.6% in Banking, 9.7% in Electronics and 6.3% in Healthcare, Education and Childcare. The Fund's top three company exposures are: 2.3% in Lloyds Banking Group PLC, 2.0% in Commerzbank AG and 1.5% in BP Capital Markets PLC.

### Leveraged Loan Market

The top performing leveraged loan industries in May were Food And Drug, Gaming/Leisure and Energy with returns (sector performance in USD terms) of 0.79%, 0.72% and 0.54% respectively. The worst performing loan industries were Media/Telecommunications, Consumer Durables and Retail with returns of -0.87%, -0.61% and -0.38% respectively.

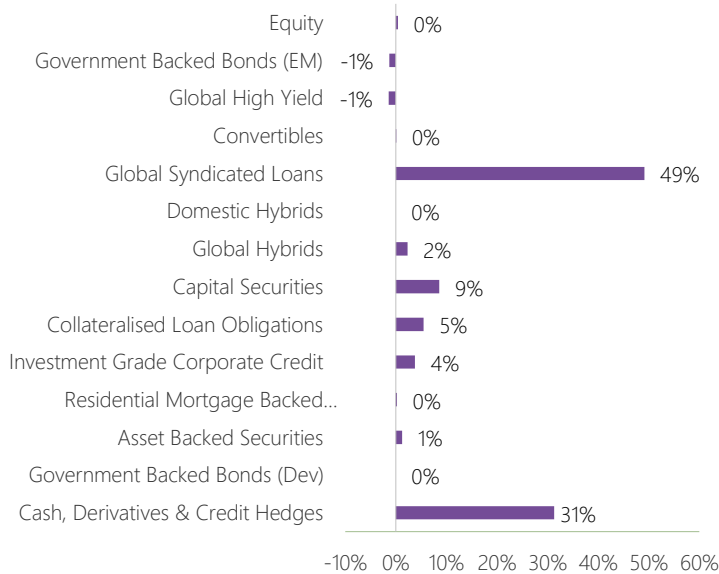
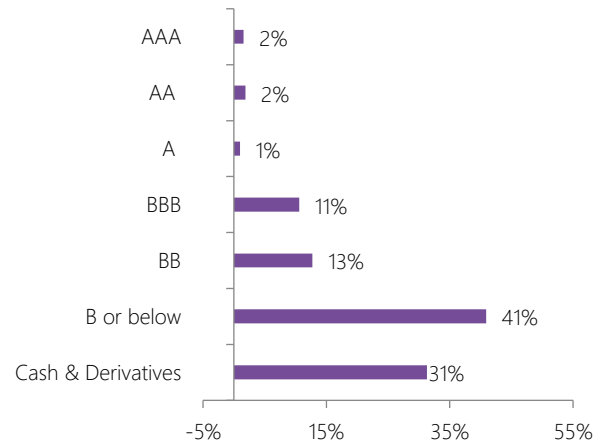
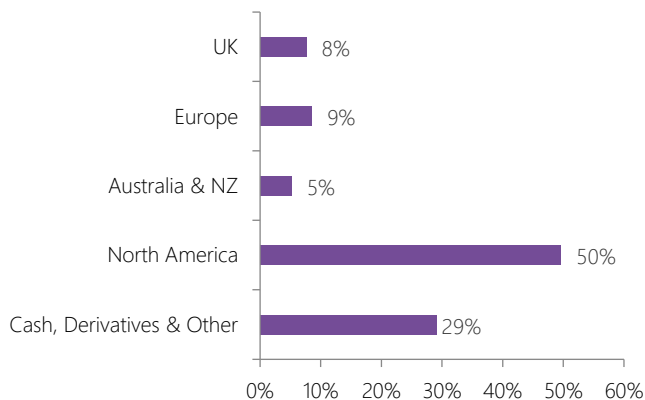
