Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of -1.98% for the month, underperforming the benchmark by 2.28%. The top performing contributors to performance included Global Syndicated Loans, Collateralised Loan Obligations (CLO) and Asset Backed Securities (ABS); whilst the bottom performing contributors included Capital Securities, Investment Grade Credit and Residential Mortgage Backed Securities (RMBS).

Portfolio Asset Allocation

During the month, exposures to Basis Trades, Capital Securities and Global High Yield increased, whilst exposures to Global Syndicated Loans, Investment Grade Corporate Credit and Convertibles decreased. Current asset allocations are 38.7% in Global Syndicated Loans, 12.3% in Capital Securities, 5.9% in Collateralised Loan Obligations, 2.4% in Global Hybrids, 1.3% in Asset Backed Securities, 0.5% in Equity, 0.3% in Residential Mortgage Backed Securities, 0.3% in Investment Grade Corporate Credit, 0.2% in Global High Yield, -1.3% in Government Backed Bonds (EM) and 39.5% in Cash, Derivatives & Credit Hedges.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 11.7% in Banking, 8.3% in Electronics and 5.9% in CLO. The Fund's top three company exposures are: 2.4% in Lloyds Banking Group PLC, 1.6% in Commerzbank AG and 1.6% in BP Capital Markets PLC.

Leveraged Loan Market

The top performing leveraged loan industries in June were Consumer Durables, Media/Telecommunications and Housing with returns (sector performance in USD terms) of 3.54%, 2.84% and 2.74% respectively. The worst performing loan industries were Food And Drug, Energy and Utility with returns of 0.77%, 1.30% and 1.54% respectively.

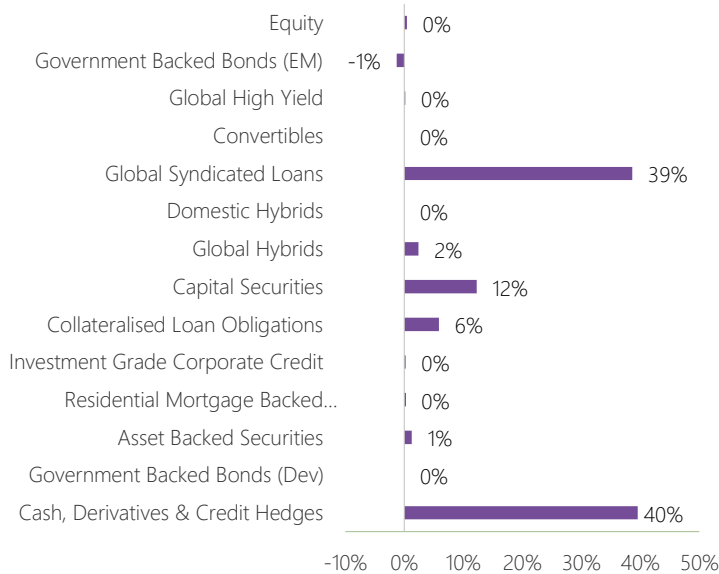
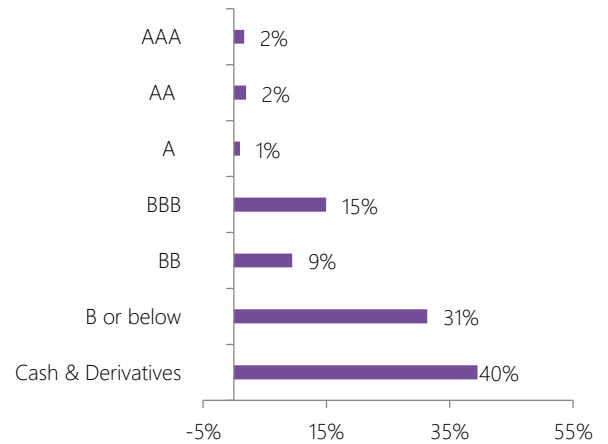
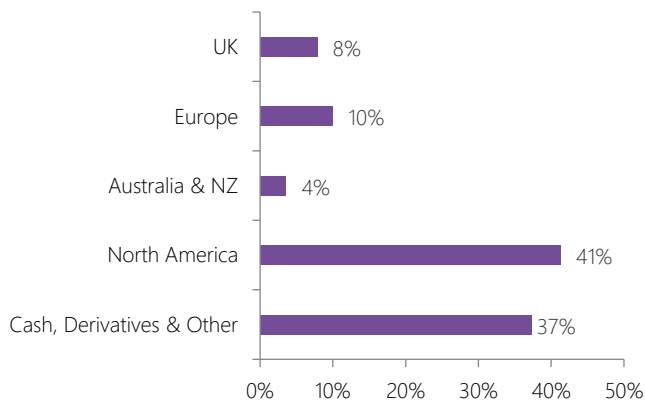
