Portfolio and Market Returns

The Bentham Syndicated Loan Fund NZD had a total return (after fees) of 1.93% in the month of June, underperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into NZD) by 0.29%. On a before fees basis the fund returned 1.97% for the month, underperforming the benchmark by 0.25%.

Fund Statistics

At month end, the Fund had a yield to maturity of 11.23% and running yield of 8.95%, with the credit yield spread decreasing by 31 bps to 553 bps during the month. The Fund had an interest rate duration of 0.48 years and credit duration of 2.66 years.

Leveraged Loan Market

The discount margin (3 year) for the Index decreased by 48 bps during the month to 581 bps.

The top performing leveraged loan industries in June were Consumer Durables, Media/Telecommunications and Housing with returns (sector performance in USD terms) of 3.54%, 2.84% and 2.74% respectively. The worst performing loan industries were Food And Drug, Energy and Utility with returns of 0.77%, 1.30% and 1.54% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 14.1% in Electronics, 10.2% in Healthcare, Education and Childcare and 8.3% in Diversified/Conglomerate Service. The Fund's top three company exposures are 1.3% in Polaris Newco, 1.0% in Hub International and 1.0% in Hyland Software. During the month, the Fund increased its exposure to Univar Solutions USA, Anchc and Ipd; with decreased exposures to SS&C Technologies, Strategic Materials and Al Aqua Merger Sub.

The current distribution rate setting was based on the running yield of the Fund as at 30 June 2022 and assumes the Fund continues to achieve an equivalent yield for FY2023. Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.



Regional Breakdown




Discount Margin and Average Price of US Loan Market
