Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of 0.89% for the month, outperforming the benchmark by 0.52%. The top performing contributors to performance included Global Syndicated Loans, Capital Securities and Global Hybrids; whilst the bottom performing contributors included Asset Backed Securities (ABS), Residential Mortgage Backed Securities (RMBS) and Investment Grade Credit.

Portfolio Asset Allocation

During the month, exposures to Basis Trades, Capital Securities and Global High Yield increased, whilst exposures to Global Syndicated Loans and Cash decreased. Current asset allocations are 31.0% in Global Syndicated Loans, 12.7% in Capital Securities, 5.9% in Collateralised Loan Obligations, 2.5% in Global Hybrids, 1.3% in Asset Backed Securities, 0.7% in Equity, 0.4% in Global High Yield, 0.3% in Residential Mortgage Backed Securities, 0.3% in Investment Grade Corporate Credit, -1.3% in Government Backed Bonds (EM) and 46.1% in Cash, Derivatives & Credit Hedges.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 12.1% in Banking, 7.8% in Electronics and 5.9% in CLO. The Fund's top three company exposures are: 2.5% in Lloyds Banking Group PLC, 1.6% in Commerzbank AG and 1.6% in BP Capital Markets PLC.

Leveraged Loan Market

The top performing leveraged loan industries in July were Information Technology, Housing and Consumer Non-Durables with returns (sector performance in USD terms) of 1.69%, 1.66% and 1.66% respectively. The worst performing loan industries were Media/Telecommunications, Gaming/Leisure and Food/Tobacco with returns of 0.34%, 0.86% and 1.04% respectively.

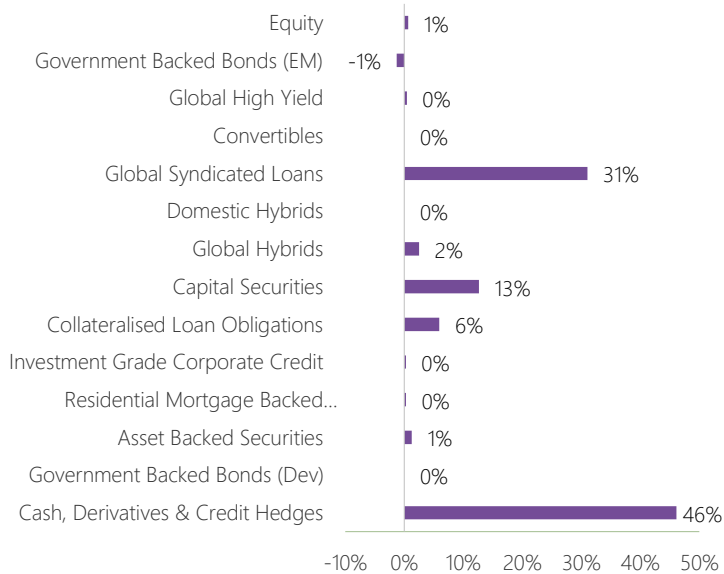
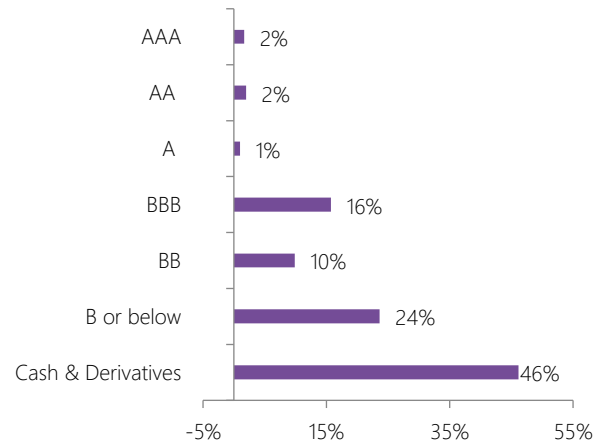
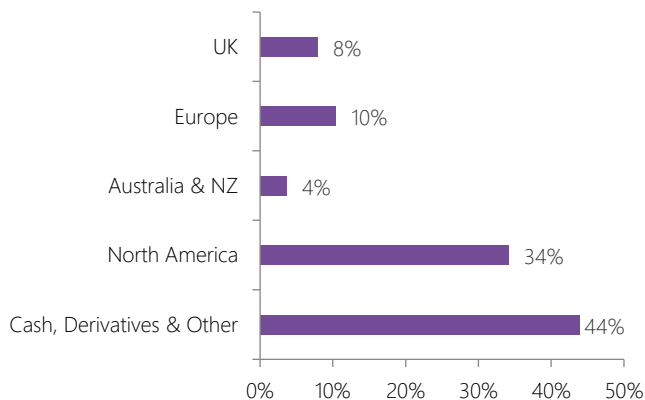
