### Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 0.20% in the month of August, remaining flat against the benchmark ICE BofAML US Cash Pay High Yield Constrained Index<sup>3</sup> (hedged into AUD). On a before fees basis the fund returned 0.25% for the month, outperforming the benchmark by 0.05%.

### High Yield Market

For the month, 15 of the 23 industries had positive returns. The top performing industries in August were Food And Drug, Cable/Wireless Video and Energy with returns (sector performance in USD terms) of 1.35%, 1.14% and 1.10% respectively. The worst performing industries were Aerospace, Retail and Metals/Minerals with returns of -0.26%, -0.26% and -0.25% respectively.

The credit yield spread for the Index increased by 4 bps during the month to 381 bps.

### Portfolio Exposures

The Fund's three largest industry exposures are 10.1% in Diversified/Conglomerate Service, 9.9% in Electronics and 6.6% in Oil and Gas. The Fund's top three company exposures are 1.1% in INTL FCStone, 1.1% in Austin and 1.1% in HealthEquity. During the month, the Fund increased its exposure to Shift4 Payments LLC Shift4 Payments Finance Sub, WESCO Distribution and Altice France; with decreased exposures to Science Applications International, New Fortress Energy and Pike.

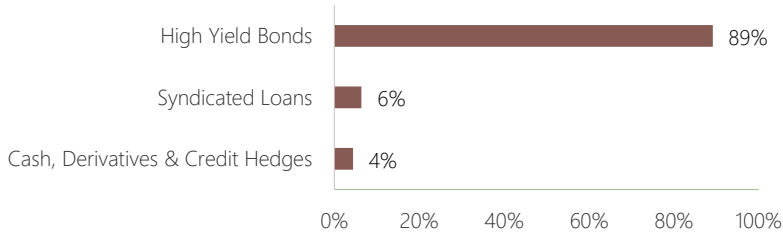

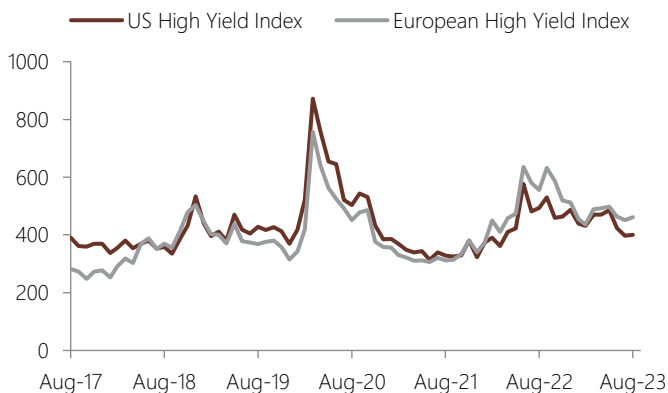
