Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of -1.44% in the month of October, underperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index3 (hedged into AUD) by 0.05%. On a before fees basis the fund returned -1.39% for the month, remaining flat against the benchmark.

High Yield Market

For the month, none of the 23 industries had positive returns. The top performing industries in October were Food And Drug, Utility and Transportation with returns (sector performance in USD terms) of -0.18%, -0.48% and -0.58% respectively. The worst performing industries were Wireless Communications, Metals/Minerals and Forest Prod/Containers with returns of -5.57%, -2.60% and -2.49% respectively.

The credit yield spread for the Index increased by 39 bps during the month to 439 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 10.0% in Diversified/Conglomerate Service, 7.7% in Electronics and 6.8% in Oil and Gas. The Fund's top three company exposures are 1.2% in INTL FCStone, 1.1% in Austin and 1.1% in HealthEquity. During the month, the Fund increased its exposure to Tronox, Techem

Verwaltungsgesellschaft 675 and Techem Verwaltungsgesellschaft 674; with decreased exposures to Asgn, Elastic and Ciena.





Portfolio Asset Allocation


