Portfolio and Market Returns

The Bentham Syndicated Loan Fund had a total return (after fees) of -0.07% in the month of October, outperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into AUD) by 0.01%. On a before fees basis the fund returned 0.00% for the month, outperforming the benchmark by 0.08%.

Fund Statistics

At month end, the Fund had a yield to maturity of 10.76% and running yield of 8.54%, with the credit yield spread decreasing by 23 bps to 558 bps during the month. The Fund had an interest rate duration of 0.53 years and credit duration of 2.65 years.

Leveraged Loan Market

The discount margin (3 year) for the Index increased by 27 bps during the month to 578 bps.

The top performing leveraged loan industries in October were Utility, Food And Drug and Energy with returns (sector performance in USD terms) of 0.70%, 0.67% and 0.60% respectively. The worst performing loan industries were Chemicals, Healthcare and Housing with returns of -0.64%, -0.39% and -0.36% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 14.1% in Electronics, 10.2% in Diversified/Conglomerate Service and 10.2% in Healthcare, Education and Childcare. The Fund's top three company exposures are 1.2% in Polaris Newco, 1.1% in Hub International and 1.0% in Ukg. During the month, the Fund increased its exposure to Citco Funding, Project Alpha Intermediate and Ciena; with decreased exposures to Zest Acquisition, GTCR W Merger Sub and Virtusa.

The current distribution rate setting was based on the running yield of the Fund as at 30 June 2023 and assumes the Fund continues to achieve an equivalent yield for FY2024. Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.




Discount Margin and Average Price of US Loan Market
