Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of 5.28% for the month, outperforming the benchmark by 4.93%. The top performing contributors to performance included Capital Securities, Global Syndicated Loans and Investment Grade Credit; whilst the bottom performing contributors included Residential Mortgage Backed Securities (RMBS), Asset Backed Securities (ABS) and Collateralised Loan Obligations (CLO).

Portfolio Asset Allocation

During the month, exposures to Global High Yield, Investment Grade Corporate Credit and Cash increased, whilst exposures to Basis Trades, Global Syndicated Loans and Global Hybrids decreased. Current asset allocations are 24.7% in Global Syndicated Loans, 11.4% in Capital Securities, 5.9% in Collateralised Loan Obligations, 2.3% in Investment Grade Corporate Credit, 1.3% in Asset Backed Securities, 1.1% in Global Hybrids, 0.6% in Equity, 0.3% in Residential Mortgage Backed Securities, -0.7% in Global High Yield, -1.3% in Government Backed Bonds (EM) and 54.5% in Cash, Derivatives & Credit Hedges.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 12.2% in Banking, 6.1% in Electronics and 5.9% in CLO. The Fund's top three company exposures are: 2.6% in Lloyds Banking Group PLC, 2.2% in Westpac Banking Corp and 1.7% in JPMorgan Chase & Co.

Leveraged Loan Market

The top performing leveraged loan industries in November were Financial, Healthcare and Aerospace with returns (sector performance in USD terms) of 1.65%, 1.61% and 1.51% respectively. The worst performing loan industries were Consumer Durables, Retail and Transportation with returns of -0.23%, 0.20% and 0.63% respectively.

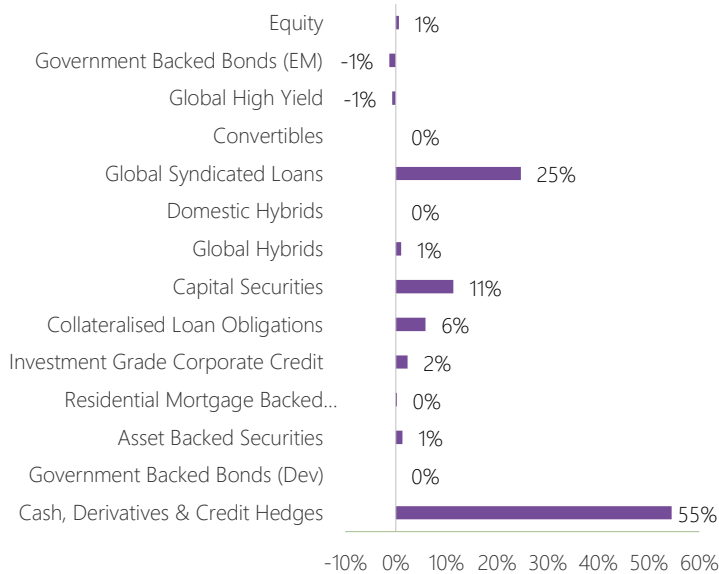
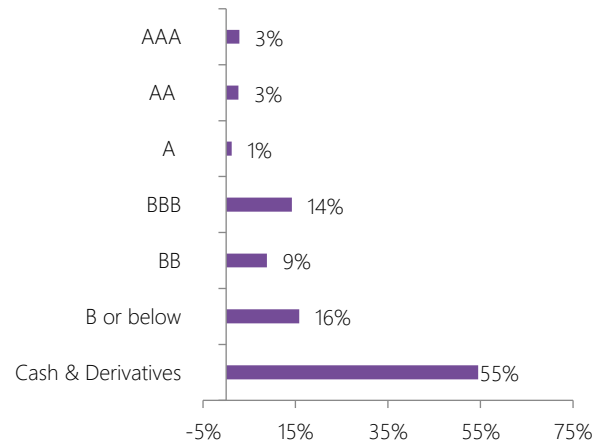
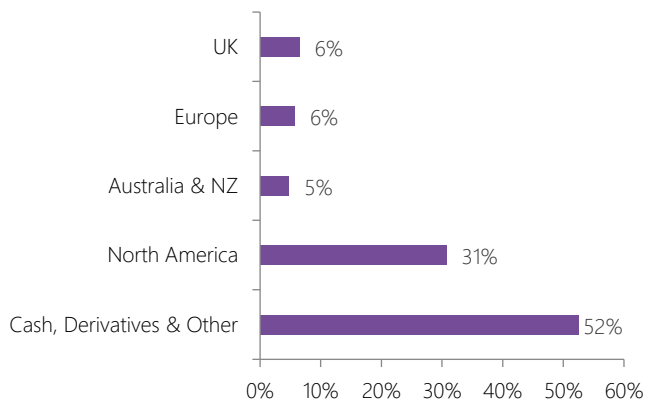
