To provide investors with a diversified exposure to the US high yield bond market with active allocation between individual securities and industries.

#### **Portfolio and Market Returns**

The Bentham High Yield Fund had a total return (after fees) of 3.67% in the month of December, outperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index3 (hedged into AUD) by 0.19%. On a before fees basis the fund returned 3.73% for the month, outperforming the benchmark by 0.25%.

### **High Yield Market**

For the month, all industries had positive returns. The top performing industries in December were Telecommunications, Cable/Wireless Video and Retail with returns (sector performance in USD terms) of 5.39%, 5.00% and 4.38% respectively. The worst performing industries were Energy, Food And Drug and Aerospace with returns of 2.11%, 2.45% and 2.74% respectively.

The credit yield spread for the Index decreased by 47 bps during the month to 332 bps.

#### **Portfolio Exposures**

The Fund's three largest industry exposures are 10.0% in Diversified/Conglomerate Service, 7.7% in Electronics and 6.1% in Finance. The Fund's top three company exposures are 1.4% in Altice Financing, 1.0% in Austin and 1.0% in HealthEquity. During the month, the Fund increased its exposure to Rockies Express Pipeline, CommScope Technologies and Grand Total; with decreased exposures to CDI Escrow Issuer, LCPR Senior Secured Financing DAC and Vt.






#### **Portfolio Asset Allocation**




#### **Regional Breakdown**
