### Portfolio and Market Returns

The Bentham Global Income Fund had a total return (after fees) of 0.21% in the month of January, underperforming the benchmark (50% Bloomberg AusBond Bank Bill Index, 50% Bloomberg AusBond Composite Index) by 0.08%. On a before fees basis the fund returned 0.24% for the month, underperforming the benchmark by 0.05%.

Investment markets were mixed in January as hopes of near-term rate cuts subsided. Developed market equities were higher while Global government bonds saw a partial reversal of the gains experienced in late 2023. Both IG credit and High Yield bond markets were weaker, while Syndicated Loans registered solid gains on a wave of refinancing as well as their floating rate characteristics.

The top contributors to performance included Capital Securities, Global Syndicated Loans and Collateralised Loan Obligations (CLO); whilst the bottom performing contributors included Bond, Global High Yield and Global Hybrids.

Even though markets are discussing a soft landing, we remain cautious on the investment return outlook because the impact of globally synchronised monetary policy that has seen a large number of interest rate hikes in quick order. While interest rates rises are on hold (in most G10 countries), monetary policy is already quite restrictive and will likely impact with a longer lag than previous rate hike cycles.

In addition, we expect tighter credit standards and increased capital costs to weigh on economic growth. Higher rates are having an impact every part of economies but in a lagged manner. In the household sector, leveraged households are spending less while household savers are benefitting from higher interest income.

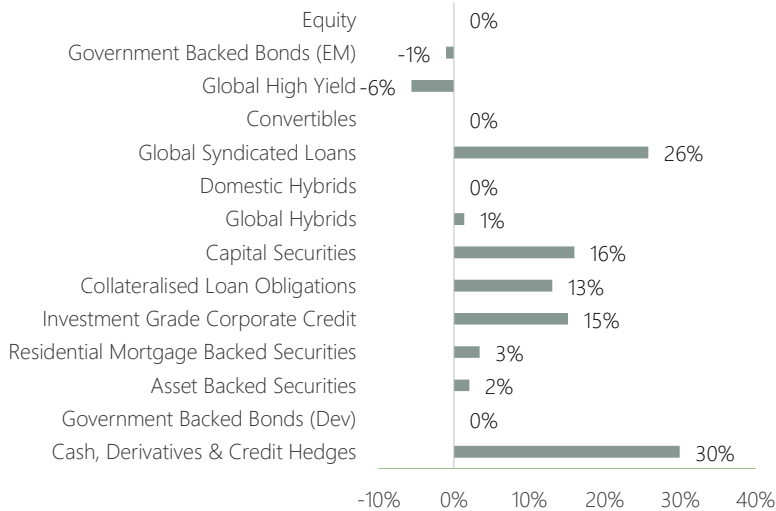
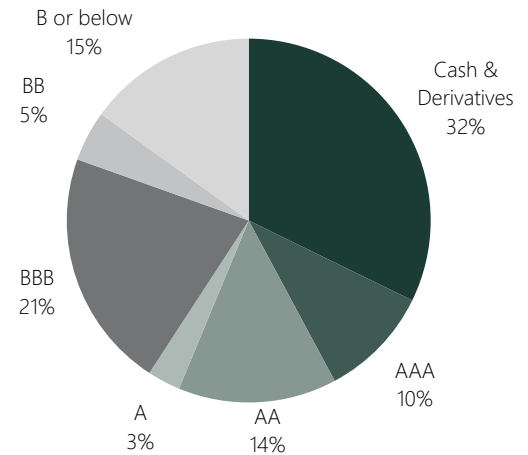
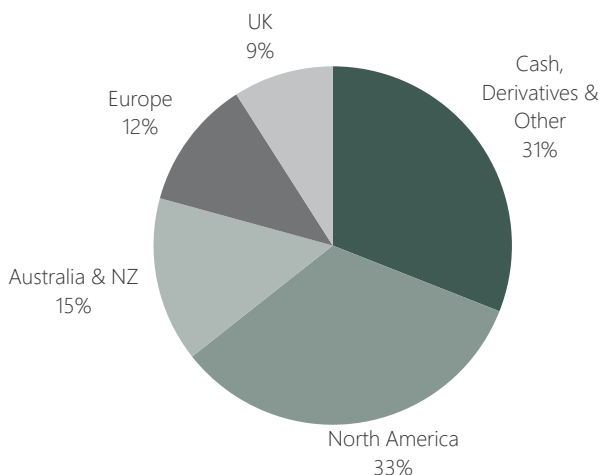
