Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of -0.19% for the month, underperforming the benchmark by 0.56%. The top performing contributors to performance included Global Syndicated Loans, Investment Grade Credit and Capital Securities; whilst the bottom performing contributors included Residential Mortgage Backed Securities (RMBS), Global Hybrids and Asset Backed Securities (ABS).

Portfolio Asset Allocation

During the month, exposures to Investment Grade Corporate Credit, Global Syndicated Loans and Basis Trades increased, whilst exposures to Cash, Global High Yield and Capital Securities decreased. Current asset allocations are 33.8% in Global Syndicated Loans, 11.2% in Capital Securities, 6.1% in Collateralised Loan Obligations, 5.9% in Investment Grade Corporate Credit, 1.4% in Asset Backed Securities, 1.2% in Global Hybrids, 0.6% in Equity, 0.2% in Residential Mortgage Backed Securities, -1.4% in Government Backed Bonds (EM), -7.9% in Global High Yield and 48.8% in Cash, Derivatives & Credit Hedges.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 12.1% in Banking, 7.4% in Electronics and 6.1% in CLO. The Fund's top three company exposures are: 2.2% in Lloyds Banking Group PLC, 2.1% in Queensland Treasury Corp and 1.9% in JPMorgan Chase & Co.

Leveraged Loan Market

The top performing leveraged loan industries in January were Retail, Utility and Food And Drug with returns (sector performance in USD terms) of 1.15%, 1.14% and 1.12% respectively. The worst performing loan industries were Food/Tobacco, Information Technology and Gaming/Leisure with returns of 0.48%, 0.50% and 0.52% respectively.



Portfolio Asset Allocation


