Portfolio and Market Returns

The Bentham Global Opportunities Fund had a before fees return of -0.58% for the month, underperforming the benchmark by 0.93%. The top performing contributors to performance included Collateralised Loan Obligations (CLO), Asset Backed Securities (ABS) and Residential Mortgage Backed Securities (RMBS); whilst the bottom performing contributors included Investment Grade Credit, Global Syndicated Loans and Global Hybrids.

Portfolio Asset Allocation

During the month, exposures to Basis Trades, Capital Securities and Global Syndicated Loans increased, whilst exposures to Investment Grade Corporate Credit, Global High Yield and Government Backed Bonds (Emerging Market) decreased. Current asset allocations are 35.0% in Global Syndicated Loans, 12.7% in Capital Securities, 7.3% in Collateralised Loan Obligations, 1.8% in Asset Backed Securities, 1.8% in Investment Grade Corporate Credit, 0.8% in Global Hybrids, 0.6% in Equity, 0.3% in Residential Mortgage Backed Securities, -1.8% in Government Backed Bonds (EM), -10.3% in Global High Yield and 51.9% in Cash, Derivatives & Credit Hedges.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 13.1% in Banking, 7.3% in CLO and 7.2% in Electronics. The Fund's top three company exposures are: 2.1% in JPMorgan Chase & Co, 2.0% in Lloyds Banking Group PLC and 2.0% in Commerzbank AG.

Leveraged Loan Market

The top performing leveraged loan industries in February were Forest Prod/Containers, Retail and Chemicals with returns (sector performance in USD terms) of 1.31%, 1.21% and 1.17% respectively. The worst performing loan industries were Metals/Minerals, Media/Telecommunications and Manufacturing with returns of 0.35%, 0.64% and 0.74% respectively.




