Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 0.15% in the month of February, underperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index³ (hedged into AUD) by 0.02%. On a before fees basis the fund returned 0.18% for the month, outperforming the benchmark by 0.01%.

High Yield Market

For the month, 16 of the 23 industries had positive returns. The top performing industries in February were Telecommunications, Wireless Communications and Forest Prod/Containers with returns (sector performance in USD terms) of 3.02%, 1.05% and 0.82% respectively. The worst performing industries were Broadcasting, Utility and Diversified Media with returns of -4.15%, -0.52% and -0.42% respectively.

The credit yield spread for the Index decreased by 31 bps during the month to 322 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 9.4% in Diversified/Conglomerate Service, 7.6% in Electronics and 7.3% in Finance. The Fund's top three company exposures are 1.5% in Altice Financing, 1.1% in HealthEquity and 1.0% in INTL FCStone. During the month, the Fund increased its exposure to Ultimate Software Group Inc The, StoneX and HUB International; with decreased exposures to Vertiv, Virtusa and First Quantum Minerals.






Portfolio Asset Allocation




Regional Breakdown
