### Portfolio and Market Returns

The Bentham Syndicated Loan Fund NZD had a total return (after fees) of 0.77% in the month of February, underperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into NZD) by 0.14%. On a before fees basis the fund returned 0.83% for the month, underperforming the benchmark by 0.08%.

### Fund Statistics

At month end, the Fund had a yield to maturity of 10.15% and running yield of 8.92%, with the credit yield spread increasing by 2 bps to 459 bps during the month. The Fund had an interest rate duration of 0.48 years and credit duration of 2.77 years.

### Leveraged Loan Market

The discount margin (3 year) for the Index decreased by 10 bps during the month to 519 bps.

The top performing leveraged loan industries in February were Forest Prod/Containers, Retail and Chemicals with returns (sector performance in USD terms) of 1.31%, 1.21% and 1.17% respectively. The worst performing loan industries were Metals/Minerals, Media/Telecommunications and Manufacturing with returns of 0.35%, 0.64% and 0.74% respectively.

### Portfolio Exposures

The Fund's three largest industry exposures are 13.3% in Electronics, 9.4% in Diversified/Conglomerate Service and 8.9% in Healthcare, Education and Childcare. The Fund's top three company exposures are 1.2% in Ukg, 1.2% in Polaris Newco and 0.8% in Virgin Media Sfa Finance. During the month, the Fund increased its exposure to American Builders & Contractors Supply, Schenectady International and Tacala Investment; with decreased exposures to Verde Purchaser, Select Medical and Presidio.

Bentham intends to achieve the distribution rate for FY2024 with taxable income. If there is a shortfall of taxable income, the distribution may possibly include a capital return.

The current distribution rate setting was based on the running yield of the Fund as at 30 June 2023 and assumes the Fund continues to achieve an equivalent yield for FY2024. Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.

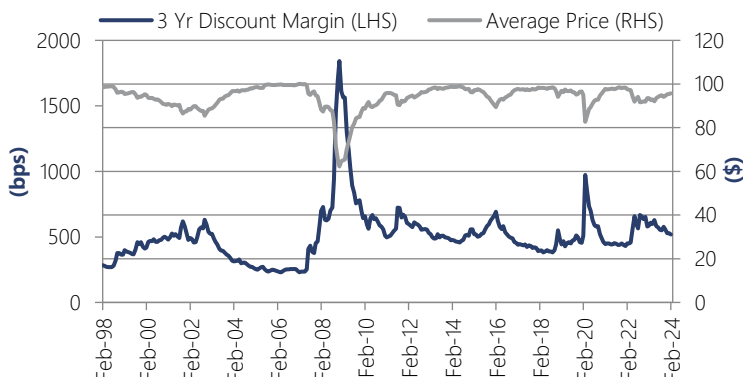
