To provide exposure to investment grade global asset backed securities (ABS) and generate stable income with some capital growth.

### **Portfolio Returns**

Active return (after fees)2

The Bentham Asset Backed Securities Fund had a total return (after fees) of 1.30% in the month of March, outperforming the benchmark (Bloomberg AusBond Bank Bill Index) by 0.93%. On a before fees basis the fund returned 1.33% for the month, outperforming the benchmark by 0.96%.

### **Portfolio Exposures**

The Fund's sector allocations are 26.9% in Australian Residential Mortgage Backed Securities (RMBS), 24.9% in US Broadly Syndicated Collateralised Loan Obligations (CLO), 21.4% in European CLO, 7.8% in UK RMBS, 7.7% in Cash & Derivatives, 7.0% in Middle Market CLO, 2.4% in Credit Card ABS, 1.2% in Aircraft ABS, 0.3% in European RMBS, 0.3% in US Commercial Real Estate (CRE), 0.0% in Personal Loan ABS and 0.0% in Auto ABS.

### **Contributors**

The top performing contributors to performance included Middle Market CLO and Australian RMBS; whilst the bottom performing contributors included European RMBS and US CRE.

### Outlook

The Fund remains focused on the higher rated tranches of ABS issuance, offering investors a high credit quality, higher yielding, secured alternatives to investment grade corporate and government bonds.

We place a high value on the structural benefits ("terms") typically included in global ABS structures to help preserve the principal of investors in the higher-rated tranches, such as cashflow priority, security, seniority, and reduction in leverage over time.




