Portfolio and Market Returns

The Bentham Syndicated Loan Fund had a total return (after fees) of 0.56% in the month of December, underperforming the benchmark (Credit Suisse Leveraged Loan Index hedged into AUD) by 0.03%. On a before fees basis the fund returned 0.63% for the month, outperforming the benchmark by 0.04%.

Fund Statistics

At month end, the Fund had a yield to maturity of 7.76% and running yield of 7.44%, with the credit yield spread decreasing by 1 bps to 375 bps during the month. The Fund had an interest rate duration of 0.35 years and credit duration of 3.33 years.

Leveraged Loan Market

The discount margin (3 year) for the Index increased by 14 bps during the month to 475 bps.

The top performing leveraged loan industries in December were Metals/Minerals, Consumer Durables and Retail with returns (sector performance in USD terms) of 1.24%, 1.08% and 1.05% respectively. The worst performing loan industries were Food And Drug, Food/Tobacco and Manufacturing with returns of -0.51%, 0.25% and 0.41% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 13.7% in Electronics, 13.2% in Diversified/Conglomerate Service and 11.0% in Finance. The Fund's top three company exposures are 1.1% in Froneri Lux Finco Sarl, 1.1% in Form Technologies Inc and 0.9% in William Morris Endeavor Entertainment Llc. During the month, the Fund increased its exposure to Icon Parent, Viant Medical and First Advantage; with decreased exposures to Polaris Newco, Claros Mortgage Trust and Presidio.

Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.

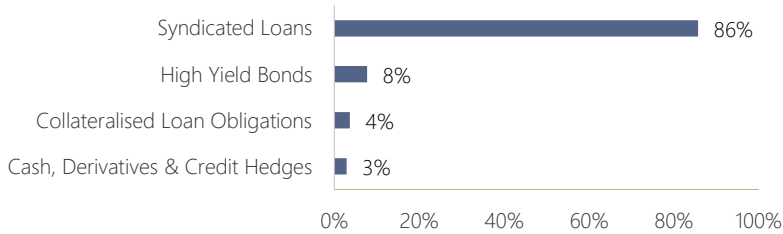

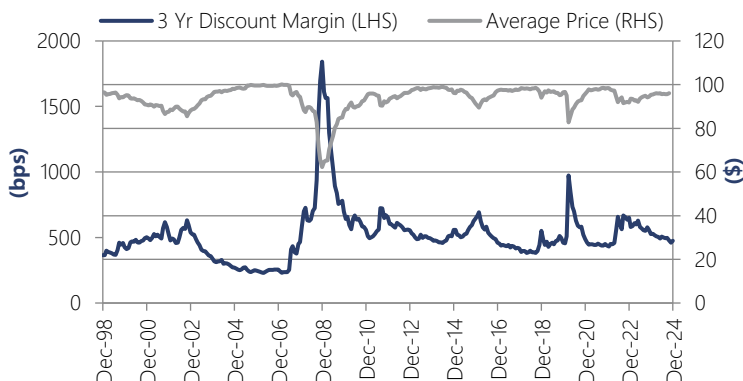
