The Fund aims to provide investors with a diversified exposure to the US high yield bond market with active allocation between individual securities and industries.

Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 0.32% in the month of October, outperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index3 (hedged into AUD) by 0.16%. On a before fees basis the fund returned 0.38% for the month, outperforming the benchmark by 0.22%.

High Yield Market

The credit yield spread for the Index increased by 10 bps during the month to 306 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 11.1% in Diversified/Conglomerate Service, 10.4% in Electronics and 6.9% in Oil and Gas. The Fund's top three company exposures are 1.0% in Panther Finance Co, 1.0% in Corelogic and 0.9% in Arcosa Inc. During the month, the Fund increased its exposure to Ball Corp, Pike Corp and Blue Racer Midstream; with decreased exposures to Adient Global Holdings Ltd, INEOS Finance PLC and Ryan Specialty LLC.





Regional Breakdown




Credit Rating Breakdown

Portfolio Asset Allocation




