The Fund aims to provide investors with a diversified exposure to the global syndicated loan market with an active allocation to investments in different industries, issuers and geographies.

Portfolio and Market Returns

The Bentham Syndicated Loan Fund had a total return (after fees) of 0.27% in the month of October, outperforming the benchmark (Morningstar LSTA US Leveraged Loan Total Return Index AUD Hedged) by 0.09%. On a before fees basis the fund returned 0.35% for the month, outperforming the benchmark by 0.16%.

Fund Statistics

At month end, the Fund had a yield to maturity of 7.33% and running yield of 7.41%, with the credit yield spread increasing by 7 bps to 391 bps during the month. The Fund had an interest rate duration of 0.31 years and credit duration of 3.31 years.

Leveraged Loan Market

The top performing leveraged loan industries in September were Distributors, Household Durables and Personal Care Products with returns (sector performance in USD terms) of 2.34%, 1.81% and 1.65% respectively. The worst performing loan industries were Automobile Components, Professional Services and Consumer Staples Distribution & Retail with returns of -10.94%, -0.21% and -0.20% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 13.8% in Diversified/Conglomerate Service, 13.6% in Electronics and 10.3% in Finance. The Fund's top three company exposures are 0.9% in Abg Intermediate Holdings 2 Llc, 0.8% in Froneri Lux Finco Sarl and 0.8% in Corelogic. During the month, the Fund increased its exposure to Icon Parent, Viant Medical and First Advantage; with decreased exposures to Polaris Newco, Claros Mortgage Trust and Presidio.

Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.

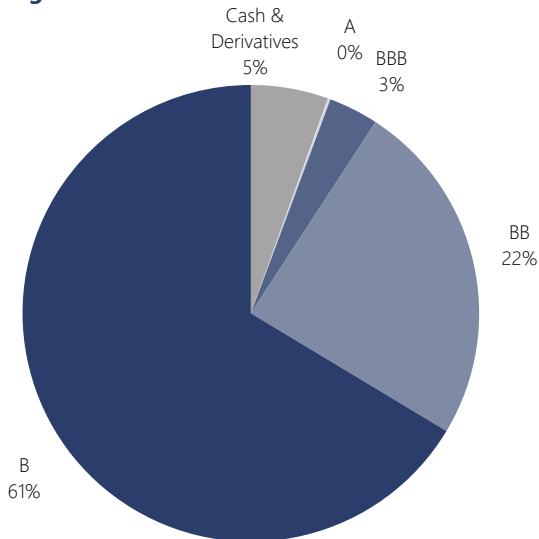
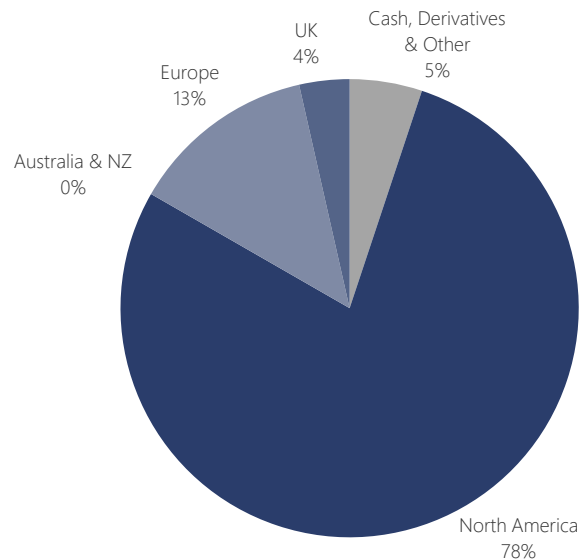
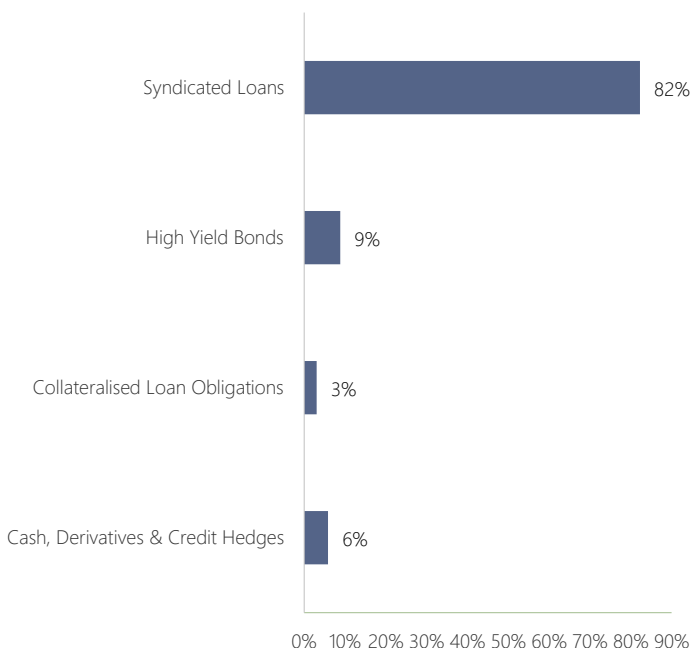
