Fund Aim

The Fund aims to provide investors with a diversified exposure to the US high yield bond market with active allocation between individual securities and industries.

Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 0.63% in the month of December, underperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index³ (hedged into AUD) by 0.01%. On a before fees basis the fund returned 0.69% for the month, outperforming the benchmark by 0.05%.

High Yield Market

The credit yield spread for the Index decreased by 16 bps during the month to 276 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 10.5% in Diversified/Conglomerate Service, 10.0% in Electronics and 7.0% in Oil and Gas. The Fund's top three company exposures are 1.0% in Corelogic, 1.0% in Arcosa and 0.9% in Cnx Resources. During the month, the Fund increased its exposure to Post Holdings Inc, CCO Holdings LLC CCO Holdings Capital and Surgery Center; with decreased exposures to Level 3 Financing, Compass Group Diversified and NIC Acquisition.






Regional Breakdown


