Fund Aim

The Fund aims to provide investors with a diversified exposure to the global syndicated loan market with an active allocation to investments in different industries, issuers and geographies.

Portfolio and Market Returns

The Bentham Syndicated Loan Fund NZD had a total return (after fees) of 0.40% in the month of December, underperforming the benchmark (Morningstar LSTA US Leveraged Loan Index hedged into NZD) by 0.14%. On a before fees basis the fund returned 0.48% for the month, underperforming the benchmark by 0.07%.

Fund Statistics

At month end, the Fund had a yield to maturity of 6.19% and running yield of 5.63%, with the credit yield spread decreasing by 3 bps to 384 bps during the month. The Fund had an interest rate duration of 0.31 years and credit duration of 3.19 years.

Leveraged Loan Market

The top performing leveraged loan industries in December were Metals & Mining, IT Services and Distributors with returns (sector performance in USD terms) of 2.03%, 1.98% and 1.75% respectively. The worst performing loan industries were Communications Equipment, Textiles, Apparel & Luxury Goods and Automobile Components with returns of -1.18%, -1.04% and -0.86% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 14.8% in Diversified/Conglomerate Service, 12.9% in Electronics and 9.1% in Finance. The Fund's top three company exposures are 0.9% in Corelogic, 0.8% in Abg Intermediate Holdings 2 and 0.8% in Froneri Lux Finco. During the month, the Fund increased its exposure to Pye-Barker Fire & Safety, Mdpk 2023-61a and Imola Merger; with decreased exposures to NIC Acquisition, Alliant Holdings Intermediate and Level 3 Financing.

The current distribution rate setting was based on the running yield of the Fund as at 30 June 2025 and assumes the Fund continues to achieve an equivalent yield for FY2026.

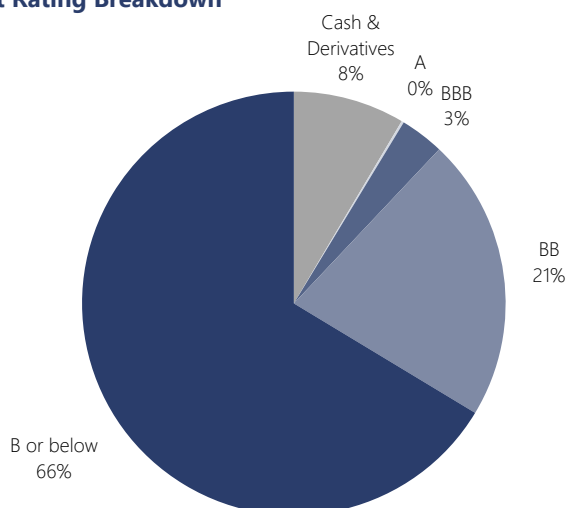

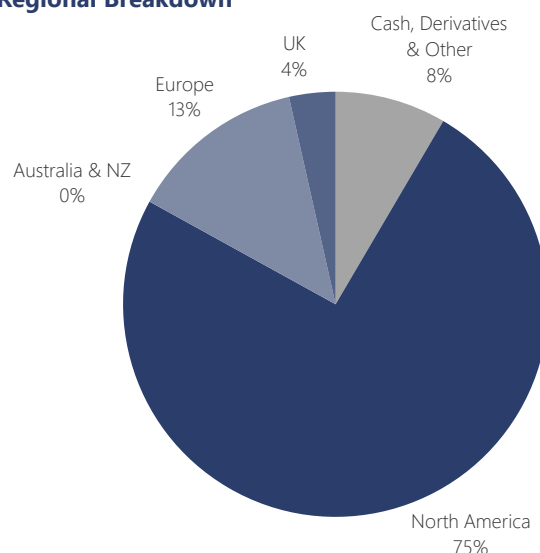

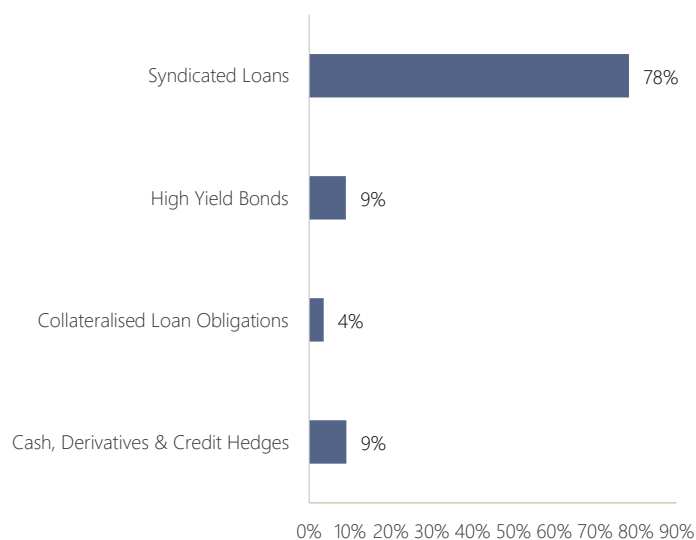
Credit Rating Breakdown
