### Portfolio Returns

The Bentham Asset Backed Securities Fund had a total return (after fees) of 0.80% in the month of February, outperforming the benchmark (Bloomberg AusBond Bank Bill Index) by 0.52%. On a before fees basis the fund returned 0.83% for the month, outperforming the benchmark by 0.55%.

### Portfolio Exposures

The Fund's sector allocations are 51.9% in Australian Residential Mortgage Backed Securities (RMBS), 14.0% in Cash & Derivatives, 13.8% in European Collateralised Loan Obligations (CLO), 10.9% in US Broadly Syndicated CLO, 5.0% in UK RMBS, 2.9% in Australian Covered Bond, 0.8% in Credit Card ABS, 0.5% in Middle Market CLO, 0.1% in Aircraft ABS, 0.0% in Auto ABS, 0.0% in US Commercial Real Estate (CRE) and 0.0% in European RMBS.




