The Fund aims to provide investors with a diversified exposure to the US high yield bond market with active allocation between individual securities and industries.

Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of -1.58% in the month of March, underperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index (hedged into AUD) by 0.41%. On a before fees basis the fund returned -1.53% for the month, underperforming the benchmark by 0.36%.

High Yield Market

The credit yield spread for the Index increased by 21 bps during the month to 328 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 11.4% in Electronics, 10.4% in Diversified/Conglomerate Service and 8.1% in Oil and Gas. The Fund's top three company exposures are 1.1% in Corelogic, 1.0% in Sunoco Lp Sunoco Finance and 1.0% in Cqp Holdco Lp Bip-v Chinook. During the month, the Fund increased its exposure to Focus Financial Partners, AmWINS and First Quantum Minerals; with decreased exposures to Murphy Oil USA, ABG Intermediate Holdings 2 and Epicor Software.

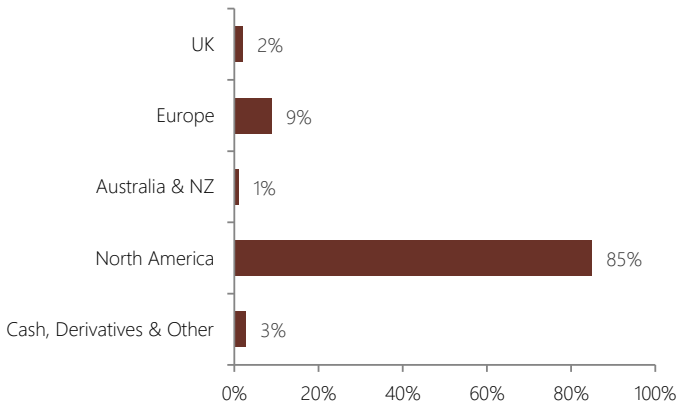
