Investment Objective

The Fund provides exposure to global credit markets and aims to generate income with some potential for capital growth over the medium to long term.

Portfolio Returns

The Bentham Global Income Fund NZD had a total return (after fees) of 0.75% in the month of June, outperforming the benchmark (50% Bloomberg AusBond Bank Bill Index (hedged to NZD), 50% Bloomberg AusBond Composite Index (hedged to NZD)) by 0.23%. On a before fees basis the fund returned 0.82% for the month, outperforming the benchmark by 0.29%.

The Fund outperformed its benchmark over the month. Key contributors to performance included interest rate positioning and the allocation to Syndicated Loans.

Market Update

Middle East tensions remained an important market driver in June. The potential resolution led to a large decline in energy prices, with spot oil falling 23%.

Global growth remained uneven. The US and parts of Asia continued to show resilience, while Europe, China, Australia and several emerging markets were softer. In China, activity was supported by exports, but domestic demand, labour markets and the property sector remained weak. Canada also entered a technical recession.

Inflation remained a key constraint for central banks: some raised rates while the Fed and others held steady, maintaining a cautious-to-hawkish stance despite elevated US CPI and core PCE.

In Australia, the RBA held rates but retained a cautious stance. Domestic activity softened, particularly through housing and household demand. Proposed tax and housing policy remained a focus for markets, given the potential impact on borrowing capacity, property activity, consumer confidence and overall growth.

In markets, the Australian government 10-year bond yield rallied, with yields falling 12bps to 4.72%. Credit spreads remained relatively flat: investment grade corporates widened 2bps, US High Yield rose 3 bps and US Leveraged Loans spreads rose 15 bps over the month.

Equity markets were volatile early in the month before recovering as energy prices eased. The Global Equities (MSCI) index (Unhedged AUD) rose 3.1% over the month. Japanese and European equities outperformed, rallying 4.6% and 5.6% respectively. US and Hong Kong markets lagged. AI-related investment and capital expenditure remained an important support for markets, although regulators are increasingly focused on the financial stability risks linked to the scale of AI-related debt issuance and autonomous market activity. SpaceX's IPO was also a landmark event, valuing the firm at a massive \$2trillion USD.

Noteworthy: Bentham's Syndicated Loan Fund delivered strong relative return for the month, outperforming the index by around 0.70% through the recovery of a workout position.

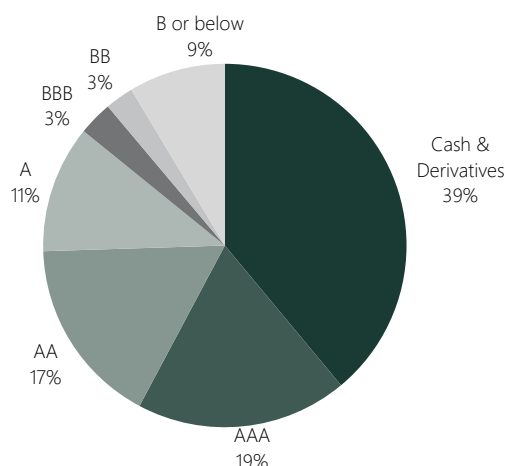
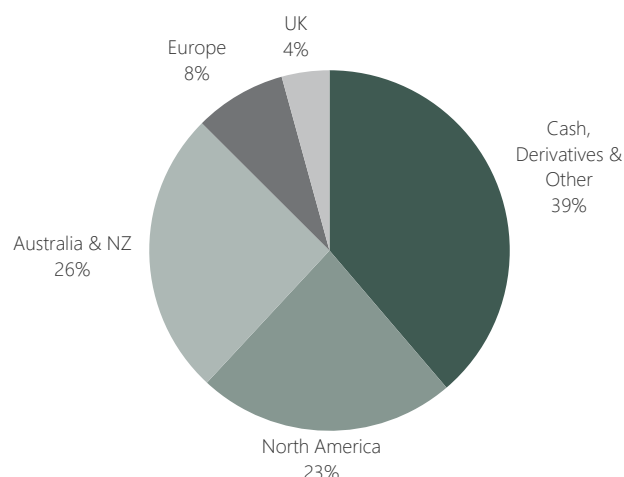
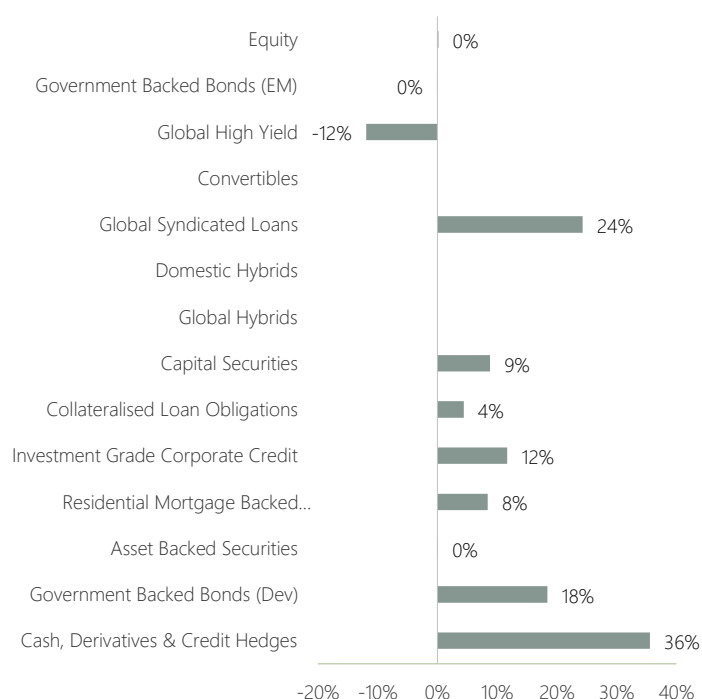
