The Fund aims to provide diversified exposure to securities across global credit markets, with the flexibility to adapt its credit and cash exposure to suit market conditions across the credit cycle, and deliver consistent levels of income.

Portfolio and Market Returns

The Bentham Global Opportunities Fund - Class I had a before fees return of 1.11% for the month, outperforming the benchmark by 0.72%. The top performing contributors to performance included Investment Grade Credit, Capital Securities and Asset Backed Securities (ABS); whilst the bottom performing contributors included Global Syndicated Loans, Asset Backed Securities (ABS) and Capital Securities.

Portfolio Asset Allocation

During the month, exposures to Grand Total and increased, whilst exposures to Grand Total and decreased. Current asset allocations are 58.8% in Global Syndicated Loans, 12.5% in Capital Securities, 11.1% in Government Backed Bonds (EM), 2.3% in Investment Grade Corporate Credit, 1.3% in Global Hybrids, 0.2% in Asset Backed Securities, -0.4% in Convertibles, -38.0% in Global High Yield and 4.4% in Cash.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 14.8% in Banking, 13.2% in Sovereign, Quasi Sovereign, Municipal and 8.0% in Finance. The Fund's top three company exposures are: 2.8% in Bnp Paribas Sa, 1.9% in National Australia Bank and 1.8% in New South Wales Treasury Corp..

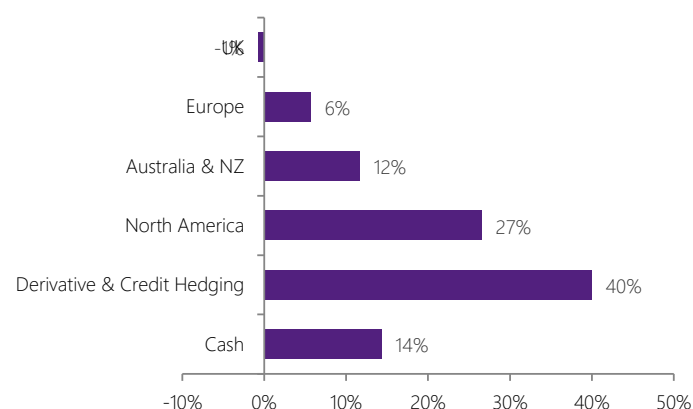

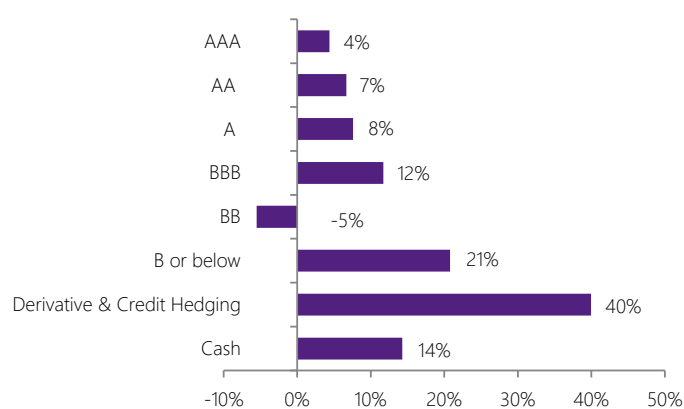

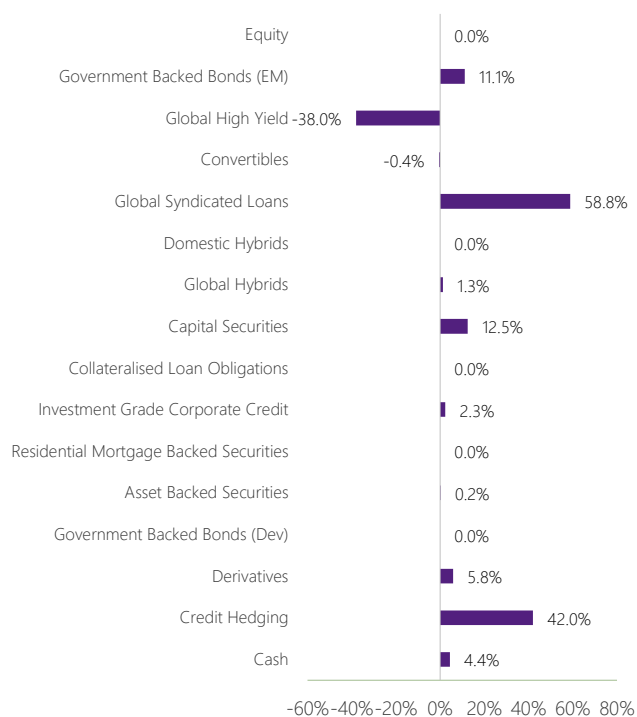
Regional Breakdown
