Fund Aim

The Fund aims to provide investors with a diversified exposure to the global syndicated loan market with an active allocation to investments in different industries, issuers and geographies.

Portfolio and Market Returns

The Bentham Syndicated Loan Fund NZD had a total return (after fees) of 0.57% in the month of June, outperforming the benchmark (Morningstar LSTA US Leveraged Loan Index hedged into NZD) by 0.55%. On a before fees basis the fund returned 0.64% for the month, outperforming the benchmark by 0.62%.

Fund Statistics

At month end, the Fund had a yield to maturity of 7.30% and running yield of 5.88%, with the credit yield spread increasing by 43 bps to 478 bps during the month. The Fund had an interest rate duration of 0.28 years and credit duration of 3.42 years.

Leveraged Loan Market

The top performing leveraged loan industries in June were Building Products, Distributors and Leisure Products with returns (sector performance in USD terms) of 1.76%, 1.61% and 1.35% respectively. The worst performing loan industries were Software, Insurance and Ground Transportation with returns of -1.66%, -1.21% and -0.57% respectively.

Portfolio Exposures

The Fund's three largest industry exposures are 12.2% in Diversified/Conglomerate Service, 12.1% in Electronics and 9.2% in Finance. The Fund's top three company exposures are 2.1% in DPC Holdings PLC, 1.1% in Hologic Inc and 0.9% in Colossus Acquireco LLC. During the month, the Fund increased its exposure to Osmosis Buyer, Nidda Healthcare and Colonial Enterprises; with decreased exposures to Doncasters US Finance, Virgin Media Bristol and AmWINS.

Actual distributions, however, can differ from this setting because of future matters which are not known or able to be presently identified.

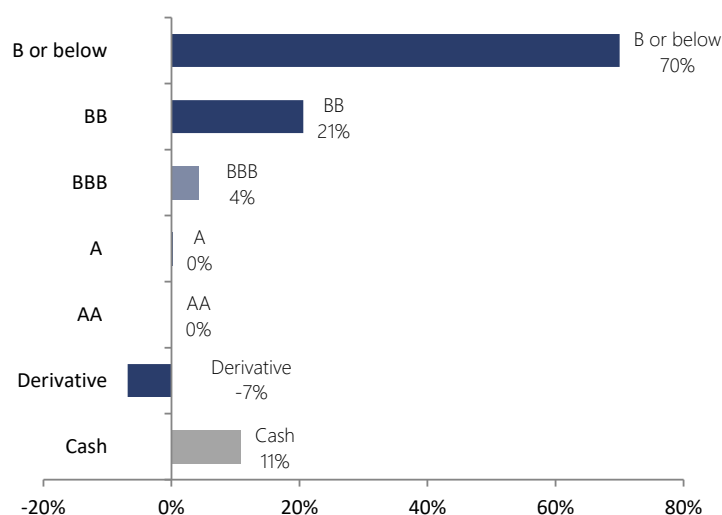

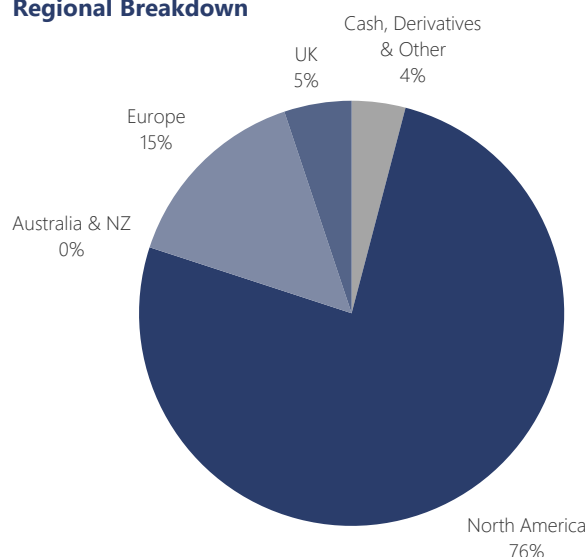

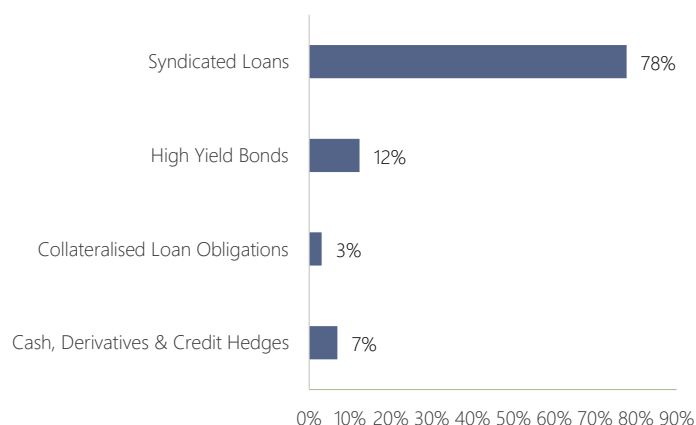
Credit Rating Breakdown
