Fund Aim

The Fund aims to provide diversified exposure to securities across global credit markets, with the flexibility to adapt its credit and cash exposure to suit market conditions across the credit cycle, and deliver consistent levels of income.

Portfolio and Market Returns

The Bentham Global Opportunities Fund - Class A had a before fees return of -0.76% for the month, underperforming the benchmark by 1.13%. The Fund lagged its benchmark over the month. Interest rate positioning detracted from performance while the allocation to Syndicated Loans and Capital Securities contributed to performance.

Portfolio Asset Allocation

In July, exposures to Grand Total and increased, whilst exposures to Grand Total and decreased. Current asset allocations are 59.7% in Global Syndicated Loans, 12.1% in Capital Securities, 9.9% in Government Backed Bonds (EM), 1.9% in Investment Grade Corporate Credit, 1.3% in Global Hybrids, 0.2% in Asset Backed Securities, -0.4% in Convertibles, -38.0% in Global High Yield and 53.4% in Cash, Derivatives & Credit Hedges.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 14.4% in Banking, 12.0% in Sovereign, Quasi Sovereign, Municipal and 7.6% in Finance. The Fund's top three company exposures are: 2.8% in Bnp Paribas Sa, 1.6% in National Australia Bank and 1.5% in Bank Of Ireland Group.

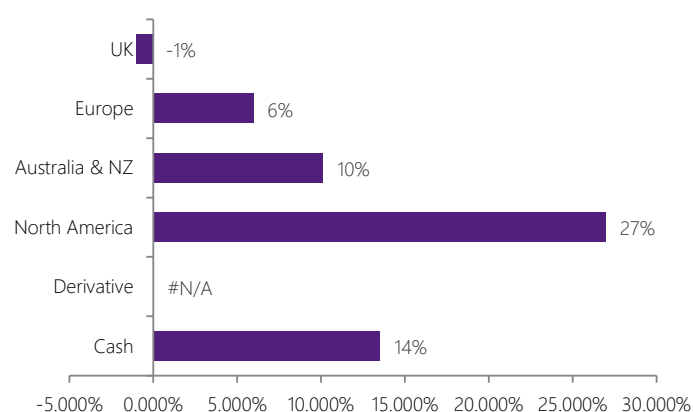

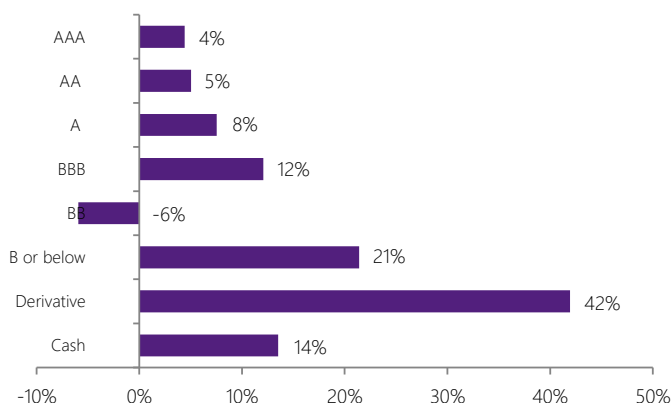

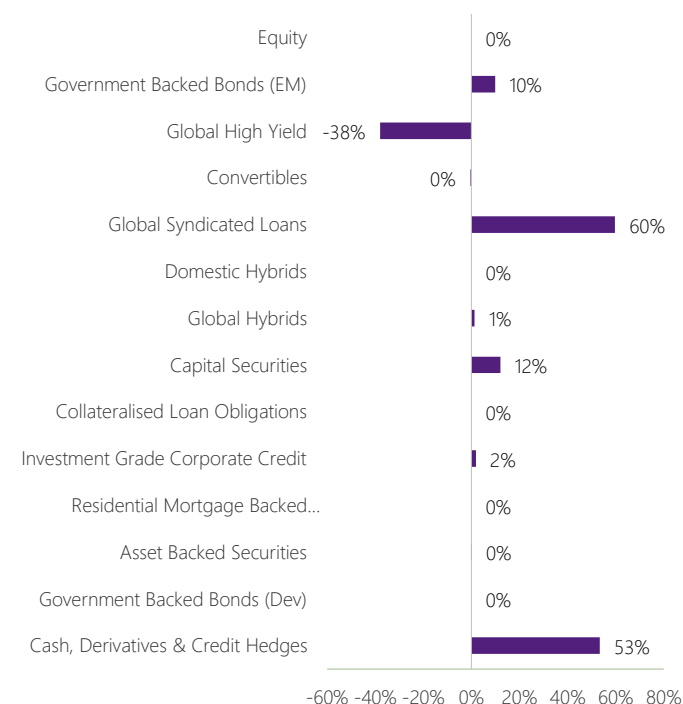
Regional Breakdown
