Fund Aim

The Fund aims to provide investors with a diversified exposure to the US high yield bond market with active allocation between individual securities and industries.

Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of -0.26% in the month of July, underperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index (hedged into AUD) by 0.03%. On a before fees basis the fund returned -0.19% for the month, outperforming the benchmark by 0.03%.

High Yield Market

The credit yield spread for the Index increased by 9 bps during the month to 281 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 10.8% in Electronics, 9.6% in Diversified/Conglomerate Service and 7.7% in Oil and Gas. The Fund's top three company exposures are 1.1% in Allied Universal, 1.0% in Cqp Holdco Lp Bip-v Chinook and 1.0% in Transdigm. During the month, the Fund increased its exposure to Telenet Finance Luxembourg Notes, Motion Bondco DAC and Talos Production; with decreased exposures to AthenaHealth, Matador Resources and Eolo.

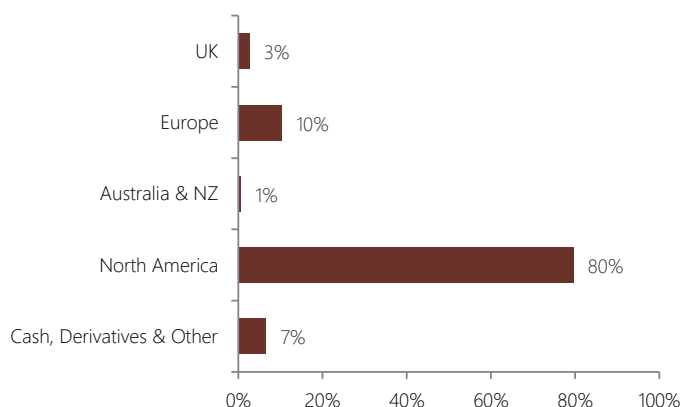

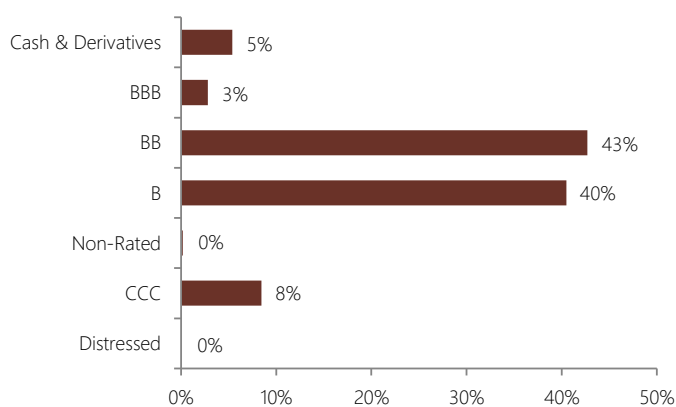

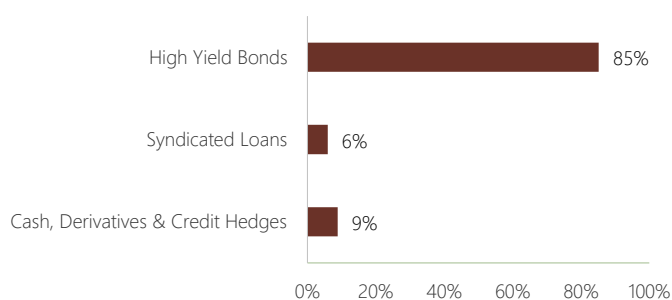
Regional Breakdown



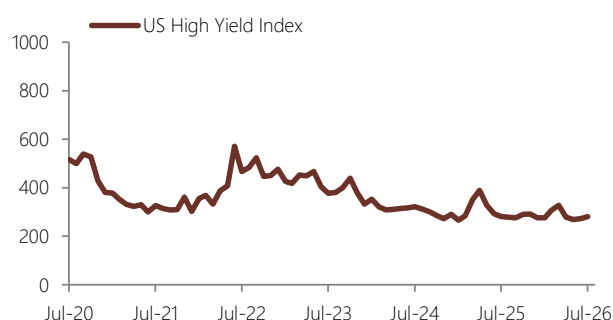
Credit Rating Breakdown
