Investment Objective

The Fund aims to provide exposure to investment grade global asset backed securities (ABS) and generate stable income with some capital growth.

Portfolio Returns

The Bentham Asset Backed Securities Fund had a total return (after fees) of -0.24% in the month of August, underperforming the benchmark (Bloomberg AusBond Bank Bill Index) by 0.62%. On a before fees basis the fund returned -0.24% for the month, underperforming the benchmark by 0.61%.

Portfolio Exposures

The Fund's main sector allocations are 64.2% in Australian Residential Mortgage Backed Securities (RMBS), 13.8% in European Collateralised Loan Obligations (CLO), 10.8% in US Broadly Syndicated CLO, 4.9% in Cash & Derivatives, 4.7% in UK RMBS, 0.9% in Australian Covered Bond, 0.6% in Middle Market CLO

The Fund lagged its benchmark over the month. Interest rate positioning detracted from performance while the allocation to Asset Backed Securities contributed to performance.

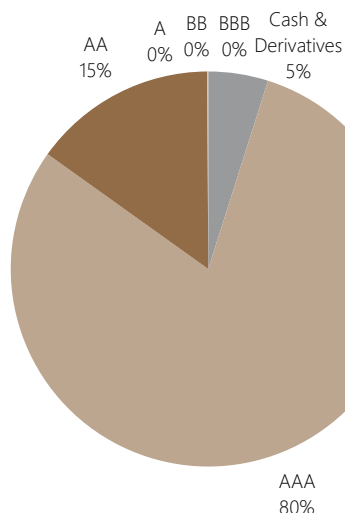
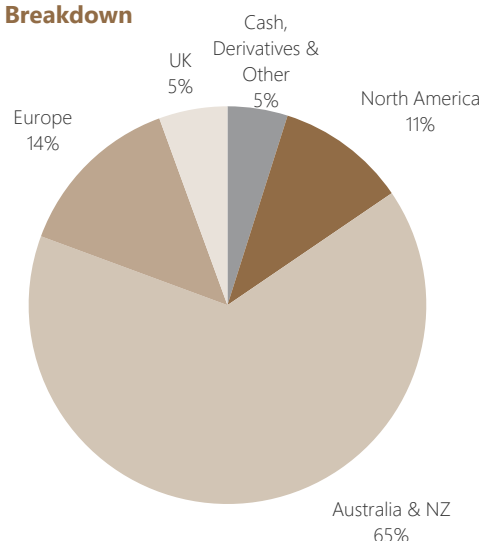
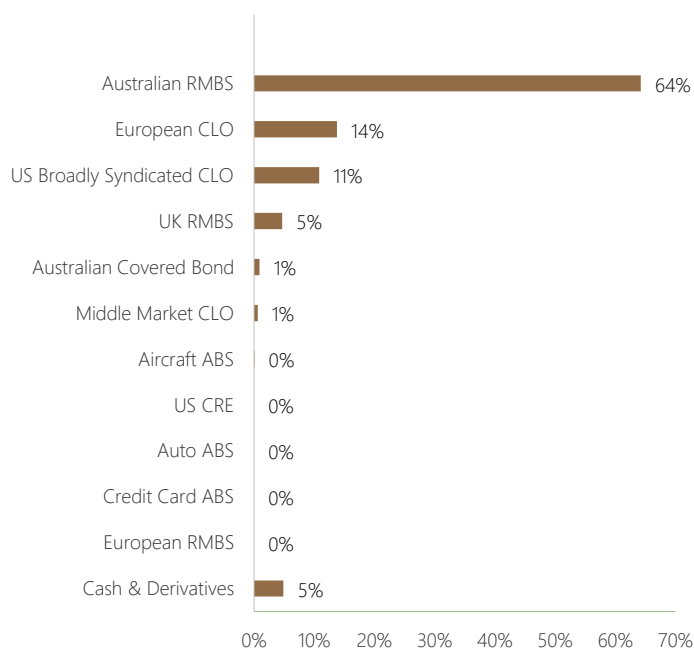
