The Fund aims to provide diversified exposure to securities across global credit markets, with the flexibility to adapt its credit and cash exposure to suit market conditions across the credit cycle, and deliver consistent levels of income.

Portfolio and Market Returns

The Bentham Global Opportunities Fund - Class I had a before fees return of -0.28% for the month, underperforming the benchmark by 0.65%. The top performing contributors to performance included Investment Grade Credit, Capital Securities and Sovereign; whilst the bottom performing contributors included Global Syndicated Loans, Asset Backed Securities (ABS) and Sovereign.

Portfolio Asset Allocation

Current asset allocations are 60.2% in Global Syndicated Loans, 46.9% in Cash & Derivatives & Credit Hedging, 12.2% in Capital Securities, 8.1% in Government Backed Bonds (Dev), 2.4% in Investment Grade Corporate Credit, 1.3% in Global Hybrids, 0.2% in Asset Backed Securities, -0.4% in Convertibles, -31.0% in Global High Yield and 0.0% in Equity.

Portfolio Industry and Issuer Exposures

The Fund's largest industry exposures are: 14.4% in Banking, 10.1% in Sovereign, Quasi Sovereign, Municipal and 7.6% in Finance. The Fund's top three company exposures are: 2.8% in Bnp Paribas Sa, 1.5% in National Australia Bank and 1.5% in Bank Of Ireland Group.

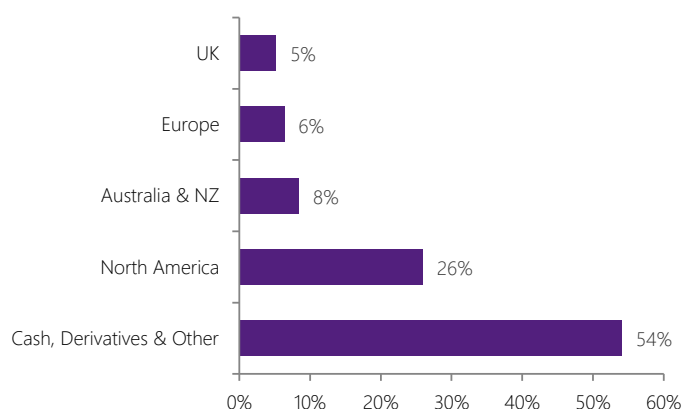

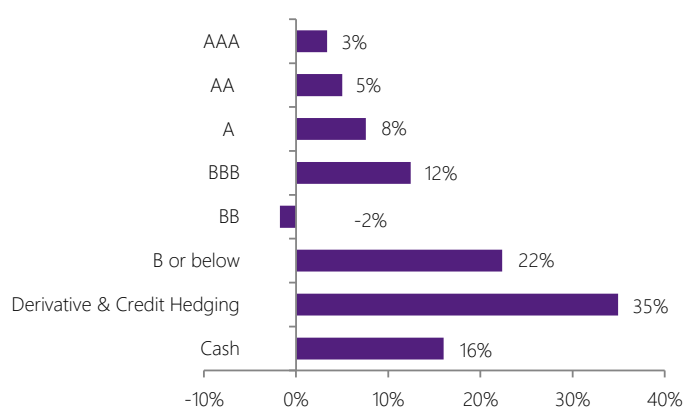

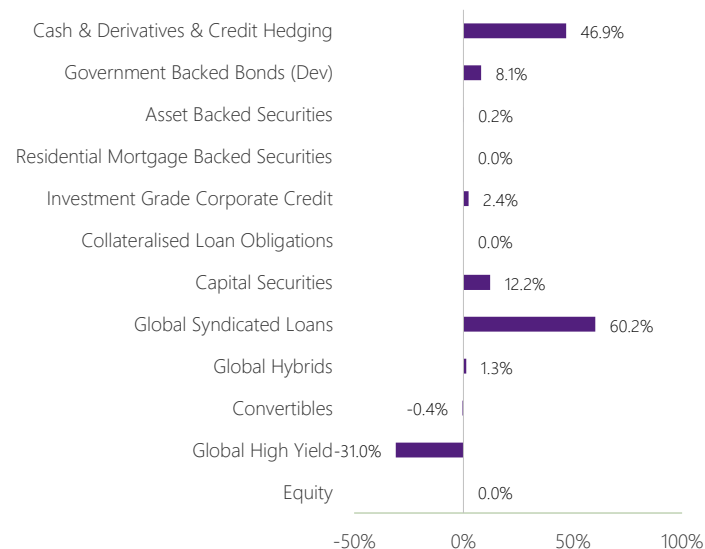
Regional Breakdown
