Fund Aim

The Fund aims to provide investors with a diversified exposure to the US high yield bond market with active allocation between individual securities and industries.

Portfolio and Market Returns

The Bentham High Yield Fund had a total return (after fees) of 1.00% in the month of August, underperforming the benchmark ICE BofAML US Cash Pay High Yield Constrained Index (hedged into AUD) by 0.02%. On a before fees basis the fund returned 1.05% for the month, outperforming the benchmark by 0.03%.

High Yield Market

The credit yield spread for the Index decreased by 21 bps during the month to 260 bps.

Portfolio Exposures

The Fund's three largest industry exposures are 10.8% in Electronics, 8.9% in Diversified/Conglomerate Service and 7.8% in Oil and Gas. The Fund's top three company exposures are 1.2% in Ahead Db, 1.1% in Allied Universal and 1.0% in Austin. During the month, the Fund increased its exposure to American Airlines Inc AAdvantage Loyalty IP, Focus Financial Partners and Telenet Finance Luxembourg Notes; with decreased exposures to AMN Healthcare, GB AIT Buyer and Albion Financing 1 SARL Aggreko.

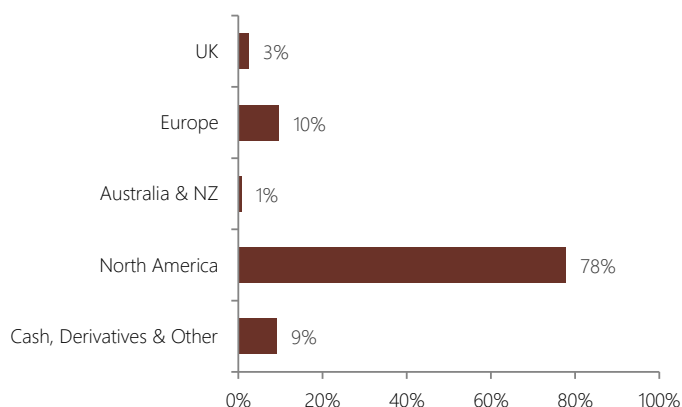

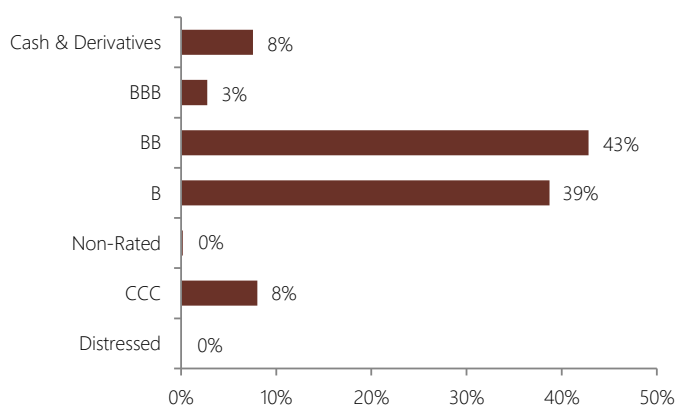

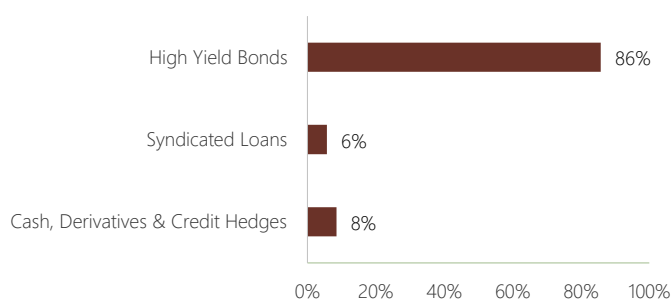
Regional Breakdown



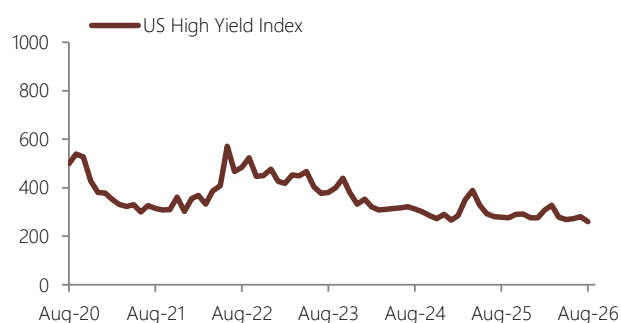
Credit Rating Breakdown
